
E-60 & E-60H MOTOR REPLACEMENT

Under Meyer Products continuing Products Improvement Program, the E-60 and E-60H electric motor part number 15689 (12V) and 15767 (24) Single Terminal, used in production and for service replacement will no longer be available. A new two terminal motor with separate terminals for (+) positive and (-) negative cable connections is now available.

Service replacement of the single terminal motors require a new motor mounting plate be installed due to the drain hole location on the new two terminal motor, an extra ground cable to be attach to the D1 (-) terminal on the electric motor. This ground cable should be attached along with the standard ground cable to the grounding stud on the hydraulic unit then to the D1 (-) terminal on the electric motor, per illustration.

Please note that replacement of an existing two terminal motor on a hydraulic unit that has the motor mounting plate with the tabs requires the motor only, part number 15727.

NOTE: On older E-60, E60H and V-66 units the Motor Mounting plate will not sit flush on casting, there is an interference problem. One of the bosses located on the new motor mounting plate interfers with a bolt head used to attach the Fenner pump to the sump casting. Due to the height of the Fenner Pump one of the bolts will require that the head of the bolt be ground down to clear boss during assembly.

DO NOT GRIND ON THE MOTOR MOUNTING PLATE.
